Initially the Action taken report of the previous meeting held on 28-12-2022 was reviewed and accepted by the committee.

The agenda wise discussion taken place and decision taken thereon is mentioned below:-

1. IA Cost –fund releasing

The I.A had requested to release the balance funds unde4r I.A cost. Fund sanctioned :Rs. 5,20,000/- Fund released : Rs. 4,68,000/- Balance amount available : Rs. 52000/- The working committee after detailed discussion had decided to release the amount to implementing agency only after the completion/documentation of the Project.

2.TA Cost –fund releasing.

Fund sanctioned :Rs. 5, 20,000/- Fund released : Rs. 4,16,000/- Balance amount available: Rs. 1, 04,000/- . The working committee after detailed discussion had decided to release the amount to technical agency after the completion/Documentation of the Project.

3.Hard Intervention – Supply of Machineries Balance 5% amount – fund Releasing. (Rs. 1,06,580)

The Implementing agency had requested to release the balance payment of Rs.1,06,580/- to machinery supplier . The Working Committee had detailed discussion and confirmed the working performance of Machineries from the reports furnished by I.A and T.A. During discussion, it was observed that the request made by the supplier was not made available by. I.A and hence the Committee decided to release the balance fund of Rs.1,06,580/- only on receipt of request letter from the Supplier (BSS Community Industries) by the State Office.

4. Hard Intervention - Purchase of Raw material – fund Releasing.

Fund already released Rs. 9,00,000/- (Including Rs.75,000/- for training raw material) The I.A had requested to release balance amount available under raw material head. The matter was discussed in detail and the Committee observed that the I.A has not made the transaction through bank A/c. As such the request of I.A to release balance funds was not considered now. The I.A was advised to make bank transactions henceforth and furnish the bank Statement up to 31st May'2023 showing the deposit of sale proceeds, wages to artisans and raw material utilization so as to consider the request for further decision.











5. EMD of Machineries Fund releasing – Rs. 1,12,000/-
